As long as COVID restrictions permit, we will be keeping the pool open until 8 p.m. in July and August, with the 2 additional hours being allocated to Open Swim time.

# POOL VOLUNTEERS ARE STILL NEEDED

We still need volunteers for the following time slots –

- Monitor/Tester
  - o Monday or Tuesday at 9:45 a.m.
  - o 4 openings, Monday Sunday at 6:00 p.m. (July & August only)
- Pool Opener/Closer
  - o Back-ups

The Monitor/Tester function involves testing the pool water and doing a couple of other monitoring tasks (e.g., checking to make sure the emergency phone is working). It takes less than ½ hour.

Opening and closing the pool involves removing or putting on the pool blanket, removing or installing the robot vacuum, scooping debris off the pool surface and some tidying up of the deck area.

### A REQUEST TO CCRA DOG OWNERS

Board members continue to receive complaints about dog owners who allow their dogs to run off leash on the former golf lands, or, who fail to pick up and remove dog waste in a sanitary manner. The CCRA expects our resident dog owners to rigorously comply with Township pet control requirements and bylaws. Although these lands are currently owned by Scugog Township, CCRA will continue this expectation once ownership has been transferred to us.

Please leash your dogs, pick up their waste and dispose of it via your own residence. One pet waste bag that litters these lands is one bag too many.

Should this disturbing behaviour continue, whether by CCRA owners or by non-residents, we will not hesitate to document incidents, and, if necessary, to request Bylaw and Conservation Authorities to enforce compliance.

### RESPECT FOR JURISDICTION

Recently we had an incident where a contractor entered and crossed Township property with landscaping machinery, without appropriate permit authorization or damage deposit to reach the property of one or two of our residents. Considerable damage was incurred

and an investigation is underway to determine the extent of the damage and what compensation may be expected by the Township.

The Canterbury Common Residents' Association was not consulted or involved in this situation originally but has now been drawn into it because of the impact it could have on our relationship with the Township. CCRA representatives are currently negotiating suitable easements with the Township in the area where this incident occurred, in order to ensure a smooth transfer of the ownership of the former golf course lands to CCRA.

It is very important for everyone to understand that the access strip from Waterbury Crescent, between 231 Waterbury Crescent and 235 Waterbury Crescent, to the area around the settlement pond, belongs solely to the Township of Scugog. That area can only be accessed by obtaining permission from the Township, securing their permit and paying a damage deposit.

No one in Canterbury can authorize you or your contractor to use that strip of property to get equipment to the rear of your property. It is your responsibility to obtain the required Township permit and to pay a damage deposit before any work commences. This requirement applies to all the former golf course lands while the Township continues to own them. Once ownership been transferred to the CCRA this particular strip will still belong to the Township and their requirements for crossing it will continue.

Why is it important to be aware of this? Because the contractor was trespassing on Township property.

Why is CCRA concerned? Although the Township has the right to control that strip of land, we want to continue our normal walking access.
